**RESULTS OF LAW SOCIETY ELECTION 2018**

**Senior Category**

There are 4 candidates for 4 places in the Senior Category, and they are Chia Soo Michael, Gregory Vijayendran Ganesamoorthy, Lisa Sam Hui Min (Lisa Cen Hui Min) and Tan Gim Hai Adrian. As such, there is no election for the Senior Category this year. Under section 53(1) of the Legal Profession Act, all 4 candidates are deemed to be elected.

All 4 candidates are current Council members. Chia Soo Michael has served in Council since 2014; Gregory Vijayendran Ganesamoorthy, the current President, has served in Council since 2013; Lisa Sam Hui Min (Lisa Cen Hui Min) has served since 2011; and Tan Gim Hai Adrian, currently one of the two Vice-Presidents, has served in Council since 2013.

**Middle Category**

There is 1 candidate for 1 place in the Middle Category, and she is Simran Kaur Toor. As such, there is no election for the Middle Category this year. Under section 53(1) of the Legal Profession Act, Simran Kaur Toor is deemed to be elected.

Simran Kaur Toor is a current Council member and she has served in Council since 2011.

**Junior Category**

There are 2 places in the Junior Category and the 4 candidates for the Category are, in random order, Foo Yu Kang Wilson (Fu Yukang), Md Noor E Adnaan, Ng Huan Yong and Sui Yi Siong (Xu Yi Xiong).

The results of the Ballot held on Wednesday, 24 October 2018 are as follows:

<b>Name of Candidate</b>	<b>Number of Votes</b>
1) Foo Yu Kang Wilson (Fu Yukang)	378
2) Md Noor E Adnaan	911
3) Ng Huan Yong	825
4) Sui Yi Siong (Xu Yi Xiong)	537

Under section 51 of the Legal Profession Act, the elected candidates in the Junior Category are Md Noor E Adnaan and Ng Huan Yong.

Ng Huan Yong is a current Council member and he has served in Council since 2017. Md Noor E Adnaan will be a new addition to Council.
