### RESULTS OF ANNUAL ELECTION OF LAW SOCIETY COUNCIL 2022

#### Senior Category

There are 3 candidates for 3 places in the Senior Category, and they are Koh Choon Guan Daniel, Tan Gim Hai Adrian and Chia Boon Teck. As such, there is no election for the Senior Category this year. Under section 53(1) of the Legal Profession Act, Koh Choon Guan Daniel, Tan Gim Hai Adrian and Chia Boon Teck are deemed to be elected.

Koh Choon Guan Daniel and Chia Boon Teck are current Council members and have served in Council since 2018 and 2016 respectively. Tan Gim Hai Adrian will be returning to Council after serving from 2013 to 2020.

#### Middle Category

There are 3 places in the Middle Category and the 6 candidates for the Middle Category are, in random order, Chan Tai-Hui, Jason, SC, Tan May Lian, Felicia, Foo Guo Zheng, Benjamin, Tan Beng Hwee Paul, Low Ying Li, Christine (Liu Yingli) and Chen Jianhao Kennedy.

Chan Tai-Hui, Jason, SC, Tan Beng Hwee Paul and Low Ying Li, Christine (Liu Yingli) are currently Council members and have served in Council since 2018, 2014 and late 2016 respectively.

#### Junior Category

There are 2 places in the Junior Category and the 3 candidates for the Junior Category are, in random order, Tan Kwee Huat, Jovey, Darryl Chew Zijie and Tan Wei-Min, Sarah Ephesians (Chen Weimin).
