The Law Society has about 6,300 members and is a body established under the Legal Profession Act (the “Act”) to carry out various statutory functions prescribed under the Act, including maintaining and improving the standards of conduct and learning of the legal profession, the facilitation of the acquisition of legal knowledge by members of the legal profession, and protecting and assisting the public in matters ancillary or incidental to the law.
