Senior Category

The Senior Category of the Council 2025 election saw **eight candidates competing for four seats**. The eight candidates (in alphabetical order) were: Chacko Samuel; Chew Kei-Jin; Chia Soo, Michael; Eusuff Ali S/O N B M Mohamed Kassim; Kenneth Lim Tao Chung (Kenneth Lin Daocong); Lam Kuet Keng Steven John; Liow Wang Wu Joseph; and Sam Hui Min Lisa (Lisa Cen Hui Min).

The Middle Category of the Council 2025 election saw **four candidates competing for one seat**. The four candidates (in alphabetical order) were: Choo Zheng Xi; Eva Teh Jing Hui; Khelvin Xu Cunhan; and Sui Yi Siong (Xu Yixiong).
