- 1 All advertisements in the online directory of legal services published or to be published by the Law Society of Singapore (the 'Directory') must strictly adhere to the Law Society of Singapore's specifications.
- 2 The style, colours and fonts used in the advertisement of the Advertiser will be the style, colours and fonts as may be specified by the Law Society of Singapore.
- 3 The type and particulars of information that may be included in the advertisement of the Advertiser shall be as prescribed by the Law Society of Singapore. The maximum word limit for the description of the law practice and its services is 500 words. The maximum word limit for the description of each partner/director is 300 words (photograph optional). The maximum number of photographs of partners/directors that may be included in each advertisement is 5.
- 4 It is the sole responsibility of the Advertiser to check the accuracy of its advertisement before it is published. The Advertiser shall be solely responsible that its advertisement complies with all laws, acts, statutes, regulations, guidelines and/or directions relating to its advertisement.
- 5 The Advertiser shall indemnify the Law Society of Singapore and keep the Law Society of Singapore fully and effectively indemnified against any and all losses, damages, claims, demands, actions, costs (including legal fees), charges, expenses and liabilities of whatsoever nature incurred by the Law Society of Singapore arising, directly or indirectly, out of or in connection with the advertisement of the Advertiser and the contents thereof or any part thereof.
- 6 The Law Society of Singapore shall not be held liable for any errors in the information contained in any of the advertisements in the Directory, whether or not such errors were made by the Advertiser.
- 7 The Law Society of Singapore shall have the absolute discretion in determining the placement (within each class or category) of advertisements in the Directory. The Law Society of Singapore shall be entitled to make such editorial changes as it deems fit to the advertisement.
- 8 Time is of the essence. The Advertiser shall comply with all timings and deadlines specified by the Law Society of Singapore.
