RESULTS OF LAW SOCIETY OF SINGAPORE'S ELECTION FOR COUNCIL 2026

Senior Category

The Senior Category of the Council 2026 election saw **four candidates competing for three seats**. The four candidates (in alphabetical order) were: Koh Choon Guan Daniel; Manimaran s/o Arumugam; Ramesh s/o Selvaraj; and Tan Cheng Han.

The ballot results from Tuesday, 28 October 2025, are as follows:

Pursuant to Section 51 of the Legal Profession Act 1966, the successful candidates in the Senior Category are Koh Choon Guan Daniel, Ramesh s/o Selvaraj; and Tan Cheng Han.

Koh Choon Guan Daniel and Tan Cheng Han are current Council members.

Ramesh s/o Selvaraj will be a new addition to Council.
